

### **COOKIE POLICY**

This document contains all you need to know about the cookie policy adopted by Mevis SpA as data controller.

#### What are cookies

Cookies are small text files that websites visited by a user send and store on the user's computer or mobile device, so that they can be transferred to the same websites the next time the user visits them. Cookies allow a website to remember the actions and preferences of users.

There are different types of cookies, with different characteristics and functions, which may remain on the user's computer or mobile device for different periods of time. In particular, these include:

- ✓ **Session cookies**: which are automatically deleted when the browser is closed;
- ✓ **Persistent cookies**: which remain on the user's computer or mobile device until a given expiry date.

### Types of cookies used by the Site

In order to optimise the user's browsing experience on our website, we use technical cookies, i.e. cookies that are essential to the operation of the website or that are required to carry out activities requested by the user.

More specifically, the following types of cookies are used:

**Analytical/performance cookies**: cookies that allow us to recognise and count the number of visitors and to see how visitors navigate the website. This helps us to improve the responsiveness and operation of the website, for example by ensuring that users can find what they are looking for without difficulty.

### Cookie: \_ga | Name: Google Analytics

Purpose: this is a web analysis service provided by Google Inc. It monitors the use of our website and allows us to estimate the size and usage habits of our audience. Certain information is shared with Google. You can find out more about Google Analytics on the Google website, https://

Expiry: 2 years

**Functionality cookies**. These are used to recognise you when you return to our website. This allows us to tailor our content to you, greet you by name and remember your preferences (for example, language choice or geographical area).

Cookie: banner | Name: Banner

Purpose: to remind users to close the video bar

Expiry: 30 days

Cookie: cookie | Name: cookie

Purpose: to remind users to close the cookie bar

Expiry: 30 days

<u>This website does not use "profiling cookies"</u>, i.e. cookies used to create profiles of users and send advertising messages based on the preferences shown by the user when browsing the Internet. User consent is required before this type of cookie can be activated.

# Accepting or rejecting cookies

If you wish to browse this website and do not wish to allow the use of cookies (or certain types of cookies), you can block them through the settings of your browser or device, which allows you to refuse all or certain cookies. However, if your browser settings are used to block all cookies (including essential cookies), you may not be able to access the website or use certain features.
